





RoHS & REACH and SCIP CERTIFICATE OF COMPLIANCE

RoHS Based on information obtained from our component suppliers, this document certifies that ALL  products are “RoHS 3 (EU Directive 2015/863 (RoHS III) updated 2011/65/EU)” compliant, adds Category 11 (catch-all) products and adds four new restricted substances - all phthalates, and do not exceed the designated levels of Lead, Cadmium, Hexavalent Chromium, Mercury, Polybrominated Biphenyls or Polybrominated Diphenyl Ethers legislated under the provisions of the European Parliament and Council Directive on the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment (2011/65/EC) and regulations promulgated thereunder, collectively, the “RoHS Regulations.” Additionally, based on such information,  products do not contain Deca Brominated Diphenyl Ether (Deca BDE) legislated under the provisions of the European Commission Decision of 13 October 2005 (2005/717/EC), do not contain as intentional additives Perfluorooctylsulfonates (PFOS) legislated under the provisions of the European Parliament and Council Directive 2006/122/EC (30th amendment to EU Directive 76/769/EEC), and do not require any exemptions including exemption 7(c)-III (Lead in dielectric ceramic in capacitors for a rated voltage of less than 25V AC or 250V DC) and exemption 11(b) (Lead in other than Cpress compliant pin connector systems). Fully RoHS Compliant (“RoHS-6”) versions of  products (“RoHS Compliant” according to the RoHS Regulations and the April 2005 Draft Guidance Document of the RoHS Regulations) became available on January 1, 2006. All such products are Fully RoHS compliant.

REACH Based on information obtained from our component suppliers, this document also certifies that NO  products contain Substances of Very High Concern (SVHC) as listed by the European Chemicals Agency (ECHA) under the provisions of Regulation (EC) No. 1907/2006 of the European Parliament and of the council concerning the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH) per the ECHA/PR/18/01 and previous updates. The provisions of this certificate supersede and replace the provisions of all other certificates previously delivered relating to compliance with the RoHS Regulations.
